It should also be noted that business and economic competition in most countries is often limited or restricted. Competition is often subject to legal restrictions. For example : competition may be legally prohibited : as in the case with a government monopoly or a government-granted monopoly. Tariffs : subsidies or other protectionist measures may also be instituted by government in order to prevent or reduce competition. Depending on the respective economic policy : pure competition is to a greater or lesser extent regulated by competition policy and competition law. Competition between countries is quite subtle to detect : but is quite evident in the world economy. Countries compete to provide the best possible business environment for multinational corporations. Such competition is evident by the policies undertaken by these countries to educate the future workforce. For example : East Asian economies such as Singapore : Japan and South Korea tend to emphasize education by allocating a large portion of the budget to this sector : and by implementing programs such as gifted education.
