## 章节摘录

On the So-Called Semantic and Grammatical Structure of the Sentence\* Miloš Dokulil and František Daneš

In recent years syntactic investigations have undergone new revival and development. Besides synthetic works, also a series of valuable contributions in journals and miscellanies has appeared. However, it must be stated that this development suffers from a high methodological, notional and also terminological disparity, and often even from a lack of clear analysis. Thus we are convinced that in the given situation it is necessary and urgent to reconsider the general questions of sentence structure, to aim at a clarification of the basic notions and of the principles of the procedure of syntactic analysis. In this contribution we certainly do not try to present a definitive solution to the given questions; rather, ideas are presented for discussion. We take up insights of older scholars, and attempt to clarify the principal viewpoints which should be used as starting points for the analysis of syntax.

When formulating (or analyzing) a sentence, the language has to know not only the constructional material of the sentence, the words and their syntactic properties and possibilities, but also the overall construction plan of the sentence, which is determined in principle by its integral "grammatical" meaning, i.e. by an entire abstraction of the sentential content. Precisely in the sense in which the grammatical properties of words represent basically a (high-level) abstraction of the specific lexical meanings of words and of specific relationships between these meanings (certainly, these grammatical properties are not only a reflection of reality, but also an expression of the organizing principle of sentence structure).
