### 内容概要

《避免二次伤害：警察讯问言语研究》属于法律语言学研究领域，旨在运用语言学理论和方法分析、解决法律问题。

本研究中的“二次伤害”指警察的讯问言语对家庭暴力案件中作为犯罪嫌疑人的受虐女性所造成的言语伤害。

基于言语适应理论和语言评价理论，本研究建构了“多维度言语转变模型”作为研究警察话语的分析框架，从社会、文化和心理维度就警察言语进行话语分析，并得出结论：“二次伤害”问题可以通过警察讯问模式的变革——从讯问到询问的言语转变加以避免。

版权页：插图：Methodologically, this research takes an integration of inductive approach ( bottom-up ) and deductive approach ( top-down ) . It is inductive in that we start from the bottom by focusing on the data: identifying specific language devices, for instance, legal terms, imperatives, and IR exchange structure, etc., classifying them into various categories. Meanwhile, it is deductive in that the linguistic strategies originate from the top, the theories as mentioned above, which are conducive to the construction of the present theoretical framework. Contrastive analysis, though not in its original sense of describing the differences of two or more languages in applied linguistics, is also employed in this research to describe the structural ( grammatical and lexical ) differences of the speech in police interrogations and police interviewing. This analysis is intended to reveal the degrees of difficulty and comprehensibility of the police talk when they make different lexical, grammatical and discursal choices.
